



Meeting of the Open Data Governance Board (ODGB) on Open Data Via Webex Webinar - 11:00 am, Tuesday, 8th December, 2020

Welcome & Apologies

The Chair welcomed everyone to the meeting and noted that it was Denis and Daithí's last meeting.

1. Minutes of September meeting and matters arising

No amendments were received to the minutes of the September meeting circulated. These were agreed and will be published on the open data portal. Matters arising were covered in the other Agenda items for the meeting.

Action (Secretariat): Publish minutes of September meeting on the portal

2. Progress update from D/PER to include update on Open Data Directive 2019 and Implementing Act on High Value Datasets

The Open Data Unit gave an overview of progress made in implementing the Open Data Initiative for the 3 month period to end November. The progress report had been circulated in advance and will be published on the open data portal.

Some of the progress highlighted include:

➤ The 3rd Open Data Conference 'Open Data for a Data Driven Public Service Delivery' was held online on December 2nd. It was noted that the conference was very well attended with over 250 attendees.

- The Open Data Unit presented Ireland's Open Data Initiative at the EU Semic 2020 conference on October 15th.
- The number of users on the Portal continues to grow with an increase of 22% in the last 3 months.
- The Hale & Hearty project, Action No: 2019-IE-IA-0126, issued a user survey aimed at identifying the data required by the 4 user profiles being utilised for the project.

Rhoda Kerins gave an update on the Open Data and reuse of PSI directive. The first draft of the Statutory Instrument to transpose the Open Data Directive is with the Attorney General's Office and the Open Data Unit are liaising with the drafter to progress the text.

The EU Open Data committee is negotiating the first Implementing Act under the Open Data Directive and it is expected that a first draft of the text will be made available shortly. Rhoda also mentioned that issues in relation to GDPR has been raised by some countries.

It was noted that the additional workload involved in the transposition of the Directive and the management of the Hale & Hearty project will place significant pressure on the ODU on top of the unit's normal activities. Certain activities may have to be postponed to accommodate the additional workload.

3. Update on Strategic objectives

Hale & Hearty project

Rhoda Kerins gave an update on the CEF funded Hale and Hearty Action which is a strategic initiative of the ODGB. The project will focus on providing high-value datasets related to the health and wellbeing sector which will be showcased through the development of a user-friendly prototype app.

Rhoda advised that Work Packages 2 & 3 (User Scenarios and Data Preparation respectively) have commenced and were progressing well. The User Scenarios group is analysing the results of their user survey to inform the datasets required. The Data Preparation group is reviewing the list of available datasets. The Data Protection Impact Assessment (DPIA) report is due to be completed by end March 2021, this is a requirement of GDPR compliance.

Training Framework

Several meetings have been held with the OGP to discuss the training framework and a first draft of the specification has been sent to them. The ODU had met with the Data Governance Unit in the OGCIO to discuss possible training overlaps.

The Board advised that the overall aims of the training objective should be referenced and the training should allow users to utilise the data on the portal and support evidenced based decision making.

It was agreed to organise a meeting of the training sub group for the ODGB early in the New Year.

Open Data Reuse Incubator

Cianan Clancy gave a presentation on the proposed funding application that he is making under the Disruptive Technologies Innovation Fund (DTIF). The ODRI will create for the first time in Europe, a disruptive Open Data Reuse Value Chain that will deliver new disruptive pan European start-ups that exploit the release of high value government data sets which is being mandated by the European Commission. The deadline for applications is the following week and the Board were asked to revert to him with comments as soon as possible. Cianan undertook to keep the Board appraised on progress.

4. Technical Support Framework

Rhoda provided an update on the development of the technical support framework. The ODU is liaising with the ODAG on the requirements for the RFT. Several meetings have taken place with the OGP to progress the specification. It is expected the RFT will be completed by September 2021.

5. Reconstitution of the Open Data Governance Unit Board

The chair noted that Daithí MacSíthigh and Denis Parfenov are original members of the ODGB and have made significant contributions to the development of Ireland's Open Data Initiative. This will be the last meeting for Denis and Daithí. The board thanked them for their contribution.

The ODU are conducting a recruitment campaign for two new members of the Board to fill the vacancies left by Denis and Daithí. An advertisement had been published on StateBoards.ie with a closing date of Tuesday, 22nd December 2020.

It was noted that Dennis Jennings proposes to stand down as chair of the board next year.

6. Update on NORF Steering Group

Declan O'Sullivan provided an update from the NORF meetings to the Board.

7. Rob Kitchin

Rob Kitchin is a professor and ERC Advanced Investigator in Maynooth University. He is currently the principle investigator on the Programmable City project and the Building City Dashboards.

Rob gave a presentation to the Board on the 'Strategic Development of Open Data'. This focused on access to clean, complete, reliable data which is updated regularly and preferable mandated.

Rob gave an analysis of the need to develop a 'state data eco system' to commence with a root and branch review of the current ecosystem and gaps. He stressed the need for national strategic plans for data management, interoperability and preservation, and for data literacy programs.

8. ODGB Plan for 2021

The Board conducted a discussion on how best to progress the open data agenda. It was agreed that the focus of the next strategy should be to stimulate interest in open data and demonstrate the value of open data. This might be achieved by forming alliances with different stakeholders such as by developing communities of users / activists. Developing results focused outcomes, data stories, improving user engagement and how the ODGB could be more challenging as opposed to just encouraging were considered in the discussion.

It was agreed to devote most of the next Board meeting to discussing and planning the approach to the next iteration of the Open Data Strategy.

9. Any other Business

It was noted that the Risk Register will be circulated after the meeting with the minutes.

In terms of the Open Data Engagement Fund, eight projects were approved for funding under the 20/21 Open Data Engagement Fund. The applications were assessed by the subgroup of the Open Data Governance Board, with a total funding of €28,100 approved. Subsequently, one awardee has withdrawn their project due to pressures of other work. This leaves the total funding at €26,100. The funding is in the process of being approved and paid by the accounts department in PER.
